
Selvan. KOPURANSOZHAN. S, against whom the complaint was lodged by Selvi. DHARSHINI. L has, earlier, submitted vide his letter dated 04.05.2022 that he has indeed misbehaved with the complainant girl even after repeated warnings by the teachers. Based on the above letter by Selvan. KOPURANSOZHAN. S, his mother was summoned today(13.05.2022) by Students Grievance Redressal Committee(Complaint Committee) and was also inquired upon. The said meeting was held on 13.05.2022 at 10.30 AM. The Chairman of the Students Council, BPK, was also present during the above inquiry.


In the inquiry by the Students Grievance Redressal Committee (Complaint Committee) the accused student Selvan. KOPURANSOZHAN. S, II Year BVA(Applied Art), Dept. of Fine Arts, BPK, was found guilty of having committed the act as alleged by the complainant student beyond doubt.


Based on the findings of the Complaint Committee, it was decided to inflict the punishment of suspension under statutes 30 and 31 of Pondichery University Act, 1985 and Chapter X IV of the Academic Ordinance of the Pondicherry University for a period until the next examination and it was further decided that Selvan. KOPURANSOZHAN. S, II Year BVA(Applied Art), Dept. of Fine Arts, if found engaging himself in any activities that will result in defaming the institution and detrimental to any staff or students of this institution, he will be expelled from the institution without any prior notice.



MINUTES OF THE MEETING


The Students Grievance Redressal Committee was convened again on 09.02.2022 at 10.30 AM in the chamber of Principal (I/c) of BPK, where the victim Selvi. I. Nanthini, IV Year BVA (Painting) along with the classmates students Selvi.N. Susindira, IV Year BVA (Applied Arts) & Selvi. N. Kavitha, IV Year BVA (Painting) were again inquired upon. The accused student Selvan. B. Jawahar, IV Year BVA Final Year, Dept. of Fine Arts, BPK, along with his elder brother (his mother was summoned through vide memo. No.A1/BPK/ACA/2021/027, 08.02.2022) appeared before the Principal and Students Grievance Redressal Committee in the said meeting on 09.02.2022 at 10.30 AM. The Chairman & Vice Chairman of the Students Council, BPK, were also present during the above inquiry.

Based on that, the above inquiry, it was decided to rusticate Selvan. B. Jawahar, from the college under the Statutes 30 & 31 and Chapter X IV of the Academic Ordinance of the Pondicherry University.

In the inquiry by the Students Grievance Redressal Committee (Complaint Committee) the accused student Selvan. B. Jawahar, IV Year BVA(Applied Art) Final Year, Dept. of Fine Arts, BPK, was found guilty of committing the act as alleged by the victim beyond doubt.

Based on the findings of the Complaint Committee, it was decided to inflict the punishment of Rustication for the academic year 2021-22 and it was further decided that Selvan. B. Jawahar, IV Year BVA(Applied Art) Final Year, Dept. of Fine Arts, shall not be allowed to enter the campus during the academic year 2021-22 with effect from the date of issuance of this order.

Furthermore, he shall not engage himself in any activities that will result in defaming the institution and detrimental to any staff or students of this institution.
